
2012 CMS MOC Incentive Program What You Need to Know!

1. This is a new program. We expect the rules to change quickly as the program evolves. Don't expect that the rules for 2013 will be the same as the rules for 2012.

2. New for 2012

- a) The modules for 2012 have been unbundled. ABNM diplomates can only use the MOC:PQRS module. The price for using only this module is \$30. Last year the modules were not unbundled and the price for using the MOC:PQRS module was \$100.
- b) You must attest the you have completed a Part IV PPA activity in 2012. This means that you must have chosen a PPA project and made a baseline measurement. The Board will confirm this by looking at your MyMOC profile to see that you have updated your progress on your PPA project (see below).



Since the PPA requirement only began in 2011, the Board expects that most diplomates to have learned about PPA in 2011 and to have chosen a PPA project and made a baseline measurement in 2012. For most diplomates, the Board expects the 2 highlighted areas above to be checked and completed.

Diplomates certified in 2011 would only be expected to have learned about PPA.

- **3. If you are certified by the ABR and the ABNM**, you should only apply for this program through the ABNM if most of your clinical work is nuclear medicine. Diagnostic radiologists must report on 3 PQRS measures. Since there is only 1 PQRS measure for nuclear medicine, nuclear medicine physicians only need to report on this one measure.
- 4. Check with you billing office to determine if you are participating in the PQRS incentive program. If you are not participating in the PQRS program, you are not eligible to participate in the CMS MOC Incentive Program.
- 5. You should not register for the CMS MOC Incentive Program if your MyMOC profile does not say you are meeting MOC milestones. Log into your profile and you will find this information in the upper right part of the screen.

- 6. If you are registering for the CMS MOC Incentive Program as an ABNM diplomate, you can NOT use the CECity module for PQRS. The CECity PQRS module requires 3 PQRS measures and there is only one PQRS measure for nuclear medicine. Registration for the PQRS incentive must be done by your billing office.
- 7. You should NOT use the CECity patient survey module. Nuclear Medicine physicians are not required to do individual patient surveys. You are required to attest that a patient experience of care survey has been done in the last year on a department level.
- 8. Detailed instructions on how to register for the CMS MOC Incentive Program is attached. In order to register you should have the following information available.
 - a) Your ABNM ID number you can find it in the upper right part of the screen when you log onto your MyMOC profile on the ABNM website.

MOC:PQRS FAQ

Q: What is the difference between PQRI, PQRS and MOC:PQRS?

A: All are part of the Centers for Medicare and Medicaid Services' (CMS) program on Physician Quality Reporting.

- The Physician Quality Reporting System (PQRS), formerly known as Physician Quality Reporting Initiative (PQRI) is a voluntary
 reporting program that provides an incentive payment to eligible professionals who satisfactorily report data on quality measures.
 Physicians who successfully meet the criteria for PQRS reporting in 2012 will receive an incentive payment equal to 0.5% of their total
 estimated Medicare Part B Physician Fee Schedule allowed charges for covered professional services furnished during the reporting
 period.
- MOC:PQRS offers eligible physicians who have satisfactorily submitted data under PQRS the opportunity to earn an additional
 incentive of 0.5% for participating in a CMS-qualified Maintenance of Certification program "more frequently" than is required to
 qualify or maintain board certification. The "more frequently" requirements are defined by the Boards in terms of their own MOC
 requirements and cycle times.

Q: My specialty Board isn't on the list, can I still participate in MOC:PQRS reporting!

A: You can participate in CMS Physician Quality Reporting (PQRS) but not MOC:PQRS Reporting for 2012. MOC:PQRS reporting is only available to physicians whose certifying Boards have gone through a qualifying process with CMS. Nine Boards became fully qualified in 2012. All Boards will have an opportunity to participate in 2013 but will have to go through a similar qualifying process between January and June of 2013.

Q: For the patient survey requirement, what is meant by institutional or departmental level surveys?

A: Many hospitals and health care institutions routinely conduct patient surveys on either a scheduled or rolling basis—sharing the results with physicians and staff in an effort to identify strengths and areas for improvement. If you, your department or division participated in this type of survey in 2012, it will count toward meeting the requirements for MOC:PQRS, even if the results were not specific to you. If, in 2012, you have participated in a patient experience of care survey that is specific to you (e.g. through your specialty Board or society), that also counts. Another option would be to use the survey module available in this application. Please keep in mind that CMS survey requirements may not satisfy your Board's MOC requirements.

Q: Do I need to provide anything extra to my Board to prove I am fulfilling the "more frequent" requirements?

A: Not unless specifically requested. CMS requires each qualified Board to validate physician compliance with the requirements of MOC:PQRS to the best of its knowledge and to audit a percentage of the participants on an annual basis. Since MOC:PQRS is a federal program, you also may be audited by CMS or other legal entities. Your attestation statements within this application serve as initial record of participation and will be maintained by your Board and available to CMS. If you are selected for audit, you may be asked to provide additional documentation to support your attestation (e.g. CME certificates, patient experience of care surveys, or documents verifying participation in Part IV activities) and the consequences will be determined by the rules and regulations of the auditing organization (e.g. Member Board, CMS). Otherwise, your Board will continue to track your progress in MOC via their usual monitoring schedule.

Q: Who issues the MOC:PQRS payment? When?

A: All payments come from CMS. For those physicians that qualify, CMS will issue the MOC:PQRS incentive payment at the same time as the PQRS incentive payment (for 2010 reporting, most PQRS payments were issued August-September 2011). If you fail to qualify for the PQRS incentive, you will not receive the MOC:PQRS incentive. Registration fees for MOC: PQRS tools will not be refunded if you do not qualify for the 0.5% incentive payment from CMS. CMS contact information can be found at http://cms.gov/About-CMS/Agency-Information/ContactCMS/index.html.

Q: If I am certified in more than one specialty can I receive more than one incentive payment?

A: No. Physicians cannot receive more than one additional 0.5% incentive even if they complete a Maintenance of Certification Program in more than one specialty.

The Centers for Medicare and Medicaid Services (CMS) asked each qualifying specialty Board to define what "more frequently" would mean in terms of changes to their regular MOC requirements (For more information on ABNM's regular MOC requirements, click here). The American Board of Nuclear Medicine has defined the "more frequent" requirements as follows:

ABNM requires completion of more frequent activity in either Part II or Part III.

 Part II (lifelong learning and self assessment): Complete more than 25 CME credits per year averaged over a two-year cycle (more than 50 CME credits in total over two years).

Part III (cognitive skills assessment): Take the secure examination in year 8 or 9 rather than
year 10.

In addition, all participants must fulfill the following Part IV requirements:

Part IV (practice assessment and quality improvement): Complete a practice assessment
activity in 2012 including a patient experience of care survey. The patient survey component
must be fulfilled by the approved survey included in the Part IV module. Complete 2 practice
improvement modules every 5 years rather than 1 practice improvement module every 5
years.

Complete an activity related to practice assessment and a patient experience of care survey in 2012 and each year you participate in MOC:PQRS. The patient survey requirement may be fulfilled by participating in surveys administered by your institution, department or other organizations.

Participate in regular MOC. (Note: Since physicians with non-time limited specialty certificates are not required to participate in MOC in order to maintain their certificate; therefore, participation in the regular ABNM MOC program will fulfill the "more frequent" requirements.)

If you choose to participate in MOC:PQRS reporting via these products, you will need to provide your National Provider Identifier (NPI) and Board identification number upon registration. If you choose to participate in the PQRS registry option you will also need to provide your Tax Identification Number (TIN). For more information, please refer to the privacy policy link below.

CMS requires participants to attest on an annual basis to fulfilling the "more frequent" requirements and requires the American Board of Nuclear Medicine to validate this attestation. As noted above, some of the requirements -- such as participation in a department level patient experience of care survey must be met every year. Other requirements must be fulfilled by the end of your MOC cycle (which may be at a date beyond the year you receive the reimbursement from CMS).

Requirements must be completed within the calendar year. This application will remain open and accessible through December 31, 2012. Requirements for subsequent years are subject to change depending on CMS rules.

How will these tools help me to qualify for MOC:PQRS?



MOC:PQRS Attestation: Through this module, you will be able to attest to meeting the MOC:PQRS requirements, including "more frequent" participation in MOC. Upon completion, your information will be transmitted to your Member Board for validation and submission to CMS.



PQRS Reporting via a Registry: This module provides you with access to a CMS-qualified registry for PQRS reporting. The PQRI*wizara*^{6M} will give you step-by-step instructions to guide you through the reporting process.

If you choose to fulfill the PQRS reporting requirement elsewhere, for example, through Medicare Part B claims, a qualified electronic health record, a qualified data submission vendor for EHRs, or another qualified registry, you do not need to complete this module.



Patient Survey: This module provides you with access to a patient experience of care survey including step-by-step instructions for administration, tracking of progress, and access to aggregate results (survey results not shared with CMS, however, CMS may ask you to provide information about the survey). This module is optional. If your Board permits you to fulfill the MOC:PQRS requirement through participation in a patient survey administered by your institution, department, Part IV practice assessment module, or another organization, you do not need to complete this module. You may select from two options: 1) Patient Survey with Internet and/or Interactive Voice Response (IVR) and 2) Patient Survey with Internet Response Only.
